Sl. No.	The school is directed to ensure that:
1	The total number of sections of Bal Vatika shall be restricted to 03 (one sections each in Bal Vatika I, II & III respectively). The total number of sections of the school from class I to X shall be restricted to 12. The optimum number of the students shall be restricted to 40 in each section. Further, increase of sections shall be subject to specific approval of the Board on the basis of the request of the school as per affiliation by law and availability of class rooms of greater than 500 sq ft dimension.
2	There are curtain visible in the composite science lab, which may pose as a fire hazards. Thus, the school is required to remove the same within 03 months and submit the compliance.
3	The school has submitted an undertaking on its letterhead duly singed by principal and manager of the school in r/o building blocks, details of lessor along with a revised video link of the boundary wall through email dated 24-02-2023. Thus, the school is required to submit the said clarification in the compliance on SARAS Portal within 03 months.

4	The school is directed to not to use the second block for any academic activity before obtaining the revised safety certificate and approval / intimation from the Board and submit an undertaking in this regard on its letterhead duly singed by principal and manager of the school within 03 months in the compliance.
5	The library is under stocked. Thus, the school is required to procure more books and submit the invoice along with videography within 03 months in the compliance.
6	The school shall conduct training of its teachers with CoE Bengaluru within 03 months and submit the compliance.

Compliance of the above mentioned points shall be submitted within 03 months on the SARAS Portal. Failure to comply within the prescribed time shall invite financial penalty @ Rs. 50,000/- every month until compliance is submitted and shall debar the school from filling the registration and LOC of students class IX to class XII, as the case may be.

The approval of the Board as mentioned above, is subject to the following conditions:-

- 5. The school shall renew mandatory certificates from time to time.
- 6. The school shall be solely responsible for any legal consequences arising out of the use of school name/logo/society/trust or any other identity /activity related to running of school affiliated to CBSE. All legal expenses incurred by the Board, if any, arising out of these circumstances, shall be borne by the school.
- 7. Concerned Regional Office is requested to create new email id of school as per direction issued by controller of examination. This E Mail ID is used for communication with CBSE only.
- 8. The school shall not remove the documents and videography links in the mandatory disclosure section of its website.
- 9. The school shall follow the SOPs of the Board for its Laboratories, Library and sports facilities issued by the Board vide circular no 11 dated 04.10.2022.

If the compliance is not submitted with in the stipulated 3 months, the Board may enhance the penalty amount and debar the schools from filling up registration/LOC details of students of classes IX to XII, as the case may be, in the next academic session i.e. 2024-25.
